THE APARTMENTS ARE OFFERED TO FAMILIES WHO ARE UNABLE TO QUALIFY FOR ANY OTHER HOUSING BUT WHO HAVE DEMONSTRATED AN ABILITY TO WORK WITH CASE MANAGEMENT. FAMILIES MAY STAY IN THE APARTMENTS AS LONG AS THEY ARE IN COMPLIANCE WITH PROGRAM AND LEASE AGREEMENTS OR UNTIL THEY ARE ABLE TO BE ACCEPTED INTO OTHER COMMUNITY HOUSING. IN 2018, OVER 90% OF FAMILIES HAD MAINTAINED HOUSING FOR AT LEAST ONE YEAR.
